Providers offer honest feedback to suppliers and tell them whether or not they are interested.

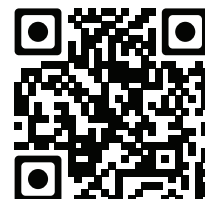

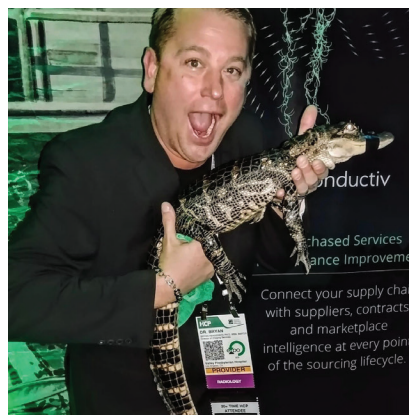

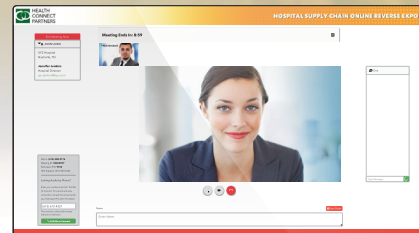
