BEYOND COMPLIANCE: STRATEGIES FOR PERI-OP EXCELLENCE AND ACCREDITATION SUCCESS WITH JC ACCREDITATION 360

CO-SPEAKER: JENNIFER REIS, MSM-HCA, HACP-CMS

Jennifer Reis leads enterprise-wide initiatives that ensure sustained compliance with regulatory and accreditation standards while driving strategic, system-level improvement. She brings deep expertise in CMS, The Joint Commission, and state regulatory frameworks, with a focus on continuous readiness, operational resilience, and sustainable compliance integration across large, complex health systems.

When The Joint Commission introduced Accreditation 360, Jennifer identified the updated Survey Process Guide as a strategic opportunity rather than a compliance risk. She spearheaded an innovative, collaborative approach—partnering closely with surgical leadership, nursing, physicians, and interprofessional staff—to redesign workflows, streamline documentation, and embed survey expectations into daily practice. This approach strengthened tracer performance, improved staff confidence, and enhanced readiness outcomes while reducing operational burden.

Jennifer is widely recognized for her ability to translate regulatory standards into practical, actionable processes that meaningfully support patient care. She is known for building strong partnerships with both clinical and non-clinical teams, including nursing, medical staff, quality and safety, facilities, risk, legal, public safety, and executive leadership. Her leadership style emphasizes transparency, shared accountability, and trust—ensuring regulatory readiness is viewed as a collective enterprise responsibility, not a siloed function.

She has also spearheaded and innovated programmatic standards for regulatory readiness, designing scalable frameworks that support consistent implementation across departments while allowing flexibility for local operations. These efforts have strengthened culture, improved engagement, and driven sustained improvements rather than episodic compliance.

In recognition of her collaborative leadership and unwavering commitment to nursing partnership and patient safety, Jennifer was honored with the Nemours Children’s Health “Friend of Nursing” Award in 2024—a reflection of her impact beyond regulatory outcomes and into workforce engagement and clinical excellence.

Cheryl has supported several high-impact initiatives, including the development of a new intensive care unit, hospital pavilion, and ambulatory surgery center. In her current role at Nemours Children’s Hospital, she partners with clinical leaders, Life Safety & Facilities teams, and construction personnel to ensure continuous readiness and alignment with Joint Commission and CMS standards. She provides clear, actionable guidance to help teams implement best practices and sustain survey readiness.

CHAIR, THE BOARD OF DIRECTORS AND PHYSICIAN MANAGING DIRECTOR, SURGICAL DIRECTIONS

Dr. Joshua Miller brings over 30 years of clinical, operational, and executive leadership in anesthesiology and pain medicine. As Chair of the Board and Physician Managing Director at Surgical Directions, he has led more than 450 hospital and health system consulting engagements—helping clients achieve double-digit ROI through surgical services optimization, anesthesiology staffing transformation, and procedural access redesign.

Previously, Dr. Miller served as a Division Medical Officer for anesthesiology, adult critical care, and interventional pain medicine for American Anesthesiology, a \$1.4 billion division of MEDNAX. There, he integrated clinical and business aspects of the company's anesthesiology services portfolio.

Prior to that he served as Corporate Medical Director of American Anesthesiology of the Southeast where he oversaw the strategic and operational direction of one of the largest anesthesiology and pain medicine groups in the U.S., responsible for 150,000 anesthetics and 125,000 pain management procedures annually across 30+ facilities. He co-developed the Quantum Clinical Navigation System, the first anesthesiology-specific quality tracking software adopted internationally and used by the ASA's AQI registry.

Double board-certified in anesthesiology and pain medicine, Dr. Miller continues to shape national strategy around perioperative efficiency, value-based care, and anesthesia workforce sustainability.
